



Spend less time switching applications or tracking down emails with iManage's integration with Microsoft Outlook




Increase findability

Accelerate accurate and relevant search results across a single repository to reduce time spent looking for information, recreating past work or losing insights




Protect the context

Why SharePoint falls short

SharePoint limits the ability to find, access, share and secure critical information – impacting productivity and collaboration, limiting institutional knowledge, and increasing security and regulatory risk.

Not fit for purpose



Waste valuable time
searching for specific information in documents and emails stuck in information silos



Work inefficiently
managing revisions, manually comparing changes and maintaining traceability for audits



Lose context without critical information, such as comments and timeline, and limited/ inaccurate metadata saved alongside documents



Experience versioning nightmares without the ability to easily see version histories and quickly identify the final or last version

iManage versus SharePoint

Intelligent and comprehensive search is **critical to your business**



Lose your advantage when you can't find what you need
searching with incomplete metadata and critical content stored inaccurately



Disjointed inefficient search requires users to conduct the same search multiple times across disparate applications to find critical information



Generic purpose search fails to understand legal context which leads to ineffective and irrelevant search results versus iManage which understands the legal context for higher accuracy and relevant answers



General purpose results lead to a poor search experience with limited ability to filter, preview or leverage intelligent 'personalized' results specific to a matter, entity or user






Specialized security & governance


Manage security with ease

Enhanced security posture with rules-based security that allows for highly specific security policies that can be applied to a single file or across folders at scale




Increase compliance and reduce risk

Detect and prevent data loss with the ability to monitor anomalous activity, providing smart alerts to secure critical knowledge work and satisfy the most rigorous regulatory audits





Insecure collaboration that fails to maintain traceability and governance by emailing attachments when users collaborate with stakeholders




Lack of clear governance without an easy way to view active security policies showing who has access to which content







As guardians of sensitive, high value content iManage AI is built into the platform with the context legal users require to leverage AI confidently without compromising confidentiality and security.





Not enhancing content intelligence as iManage AI is built into the platform to continuously increase the context and details around the content in the DMS increasing information accessibility and result accuracy


